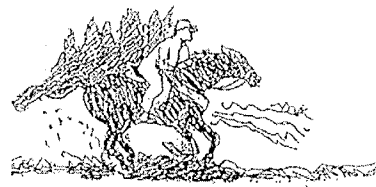


# SHORE TO SHORE TRAIL RIDE

### WARM UP RIDE

August 7, 2011

Fees as stated for 1 day

### SHORE TO SHORE

August 8-12, 2011  
5 Days- 5 Rides- 50 & 25 miles each day  
Endurance & Competitive\*  
Head Vet/Judge- Rae Birr, DVM

### COOL DOWN RIDE

August 13, 2011  
50 E, 25 LD, 25 C, 50 C  
Fees as stated for 1 day

\* August 8-12, 2011 Competitive will be held only if there are 10 paid entries on or before June 1st, 2011. No refunds once 10 entries have been obtained. Follow fee schedule for endurance entries.

## ENDURANCE

### FEES

Special rate for riders who pay before ride starts:  
1 rider- 1 horse- 5 days \$325.00  
Enter 1 day at a time- \$70.00 per day. Juniors \$25.00 per day  
Non AERC members pay a surcharge per entry, per day

### AWARDS

Ribbons for top 6 places. Ribbon and prize for best condition each day.  
Completion awards for all finisher. Prize for top horses each day.

## LIMITED DISTANCE 25

### FEES

1 rider- 1 horse- 5 days \$275.00  
Enter one day at a time \$60.00 per day, juniors \$25.00 per day.

### AWARDS

Ribbons for top 6 places. Prize for top horse each day. Completion awards for all finisher.  
Additional ribbons and awards for finisher of the 250 & 125, same horse, same rider combination.

**Vet-in starts Saturday, August 6, at 4 p.m.**

All rides will conform to UMECRA, AERC, IAHA, AHOA, and APHC standards.  
Must also have a negative coggins test to enter any division race. All judges' decisions final!

## CAMP DIRECTIONS

RIVER ROAD TRAIL CAMP- From Oscoda, Travel west on River Rd. 10 miles to River Rd. Camp. (7 & 8th)

SOUTH BRANCH TRAIL CAMP- From Oscoda and US 23, travel west on River Rd. 23 miles to Rollways Rd., turn north 3 miles to South Branch Trail Camp. (9th)

LUZERNE TRAIL CAMP- From Luzerne, go south 2 miles to Durfee Rd., turn south 1 mile to Luzerne Trail Camp. (10th)

GOOSE CREEK TRAIL CAMP- From Country Rd. 612 and Manistee River Rd., go south on Manistee River Rd. approximately 0.3 miles and turn right (west) into campground. (11th)

SCHECK'S PLACE TRAIL CAMP- From 131 and South Boardman junction (south of Kalkaska) take Supply Rd. (also called South Boardman) west to Brown Bridge Rd. and turn left (follow the Ranch Rudolph signs) approx. 3-1/2 miles. Camp is one half mile west of Ranch Rudolph. Turn left into camp. (12th)

GAREY LAKE CAMP- 8 miles east of Empire. From M-72, turn south on Plowman Rd. Go 2 miles, then turn left or east on Pettingill Rd. and continue to camp on the right (south side) of the road. (13th)
