The net effect of these adjustments decreases 2020 net income by \$535.84. \$582.20 of this change was due to the convention speaker travel expenses paid in 2019 but recognized in 2020. The other changes are minor corrections found while reconciling memberships, ride books, and newsletter prepaid accounts.
