## **NOVICE RIDE CHANGES**

The following rules were adopted in the January 2009 general meeting. They limit who can place in this division for ride awards and year end awards. Experienced riders can still ride in the novice division, but they ride for miles only. We continue to need these experienced folks to mentor our beginning riders or beginning horses, and we thank you in advance for volunteering to take a group out this season! Have fun on your rides.

#### COMPETITIVE NOVICE DIVISION

The objective of this division is to promote the entry of new riders and new horses into the sport of distance riding.

A UMECRA Novice Ride can not be longer than 15 miles. The ride must be part of the UMECRA sanctioning process. All fees apply.

- 1. The Novice division must be a one horse/rider team. To enter this division for year-end awards and individual placings, the rider must not have completed more than 3 competitive rides of 25 miles or more. They must not have entered more than 2 Limited Distance rides or more than 2 Endurance rides. Horse/rider teams not meeting this criteria may enter novice rides for mileage only.
- 2. The horse/rider team must not be entered during the official ride season in any other ride distances other than the novice division, with the exception of one 25 or 30 mile competitive ride.
- 3. Horse/rider team will use the same rules as competitive rides and including UMECRA general rules.
- 4. Novice rides will have only one division. Juniors and seniors, no matter what weight division are one division for the purpose of awards and scoring for UMECRA.
- 5. Scoring for UMECRA awards will use the current system for High Point Awards. Awards will be given to Top 5 only.
- 6. Novice riders must accumulate a minimum of 40 miles and at least 3 rides, of which one ride can be a 25 or 30 mile competitive ride for Year End Top 5 Awards.
- 7. If a UMECRA sanctioned ride offers novice classes, all fees and rules shall be observed. Novices are only eligible for year-end awards in the competitive novice division or other awards where the criteria specifically states that novice rides shall count. Novice mileage shall count for chevrons and horse mileage, but shall not be considered in determining eligibility for Restricted Mileage awards.

## OTHER RULES AND BYLAW CHANGE HIGHLIGHTS.

Novice wording was changed in the Sanctioning guidelines of the UMECRA rules. See item K. And if a ride manager cancels their ride two years in a row they will be asked to give up their ride

date. The driving awards for UMECRA have been adjusted. Singles and pairs will be competing in the same division for points and year-end awards. One bylaw change was made. The President of UMECRA does not have to be a current ride manager, but must have been a ride manager 3 of the last 5 years, or been a delegate the last two years. The secretary/treasurer position DID NOT change, at further review during the March board meeting, that bylaw change did not have the 2/3rds majority needed to pass.

# HOW MUCH SALT DOES A HORSE REALLY NEED?

I came across this in Horse Journal and it clarifies how much salt our horses really need.

Work Level (1100 horse)	Salt (grams per day)	Salt (ounces per day – 2tbls = 1oz)
Maintenance	25 grams	Just under an ounce
Light/moderate work in cool weather	35 grams	1.25 ounces
Heavy work in cool weather	50 grams(speed work) to 62.5 grams (endurance)	1.75 to 2.2 ounces
Light/moderate work in hot weather	35 grams plus a correctly balanced electrolyte replacement product given according to product directions	1.25 ounces plus a correctly balanced electrolyte given according to product directions
Heavy work in hot	50 grams (speed	1.75 ounces

#### For your consideration...

- Salt is the only mineral horses will naturally seek.
- Designer salts, said to be natural or from specific areas, give your horse no more value than inexpensive table salt
- Some natural, unrefined salts can contain toxic materials
- Salt s a chemical called sodium chloride (NaCl).
- Ensuring a daily consumption of 1 2 ounces of salt is absolutely necessary to avoid a dehydrated state
- Sea salt is not safe because the oceans are contaminated.

What about hidden salt? If your horse stays hydrated but doesn't seem to eat the free choice salt, he may be getting his salt from other sources. Some commercial feeds may contain up to 1% salt – if you feed 6 pounds per day, that's almost 1 ounce (28.4 grams) of salt – almost enough to meet his daily requirement! A supplement with 10% salt will have 2.84 grams per ounce. One more reason to check the labels!

### **UMECRA BOD MEETING**

March 14, 2009 Ho Chunk Casino, Wisconsin Dells

In Attendance: Wayne Gastfield, Angie Mikkelson, Lynn Reichert, Sharon Hahn, Peggy Pasillas, Shelly Sentyrz, Dawn Haas, Linda Mowrer, Marty Power, Julie Jackson, Maxine Bernsdorf, Theresa Meyer, Peggy Brush, Rick Nelson, Jill Feller

Guests: Tony Troyer

Meeting was called to order by President Rick Nelson.

#### Secretary report:

Minutes from the January meetings were printed in the February newsletter so copies were not distributed at the BOD meeting. Rick presented a member's concern that the bylaws were not followed when during the general meeting in January. The bylaws state the there needs to be a 2/3 majority vote to change a bylaw. During the meeting, the vote to change the secretary/treasurer criteria was a vote of 45 yes

out of 79 votes. This is not a 2/3 majority. The minutes from January 24th general meeting will be amended to reflect this change. The bylaws will remain as is for the secretary/treasurer criteria. Motion was made by Wayne to accept the minutes with this change; seconded by Theresa; motion passed.

#### Treasurer report:

The treasure's report was presented in the form of a balance sheet and a profit & loss statement from January 1- March 7, 2009. Motion made by Theresa, seconded by Max to accept report as presented: passed.

#### Agenda:

- Convention update: Dianne Schmidt, convention manager was not in attendance at the meeting; no update was provided.
- Convention guidelines: The convention guidelines were reviewed by the BOD.
- o Section 8 of the guidelines reads: All expenses and income need to be recorded and turned in to the UMECRA Secretary/Treasurer at the end of the convention. Communication with the Sec/Treasurer should be done prior to the convention to establish the 'hows' and whys of how expenses will be handled. An experienced convention manager may want to track all expenses/income on his/her own and just submit a final report while an inexperienced convention manager should work closely with the secretary/treasurer.
- o After discussion by the BOD concerning the tracking of expenses and keeping records centralized, this section was changed to: All money for the UMECRA convention will be put into the Convention Fund by the Secretary/Treasurer and all expenses for the convention will be paid through this fund. Convention managers are not to manage the money transactions of the convention individually; all money transactions are to be done through the UMECRA Secretary/treasurer. Convention managers will need to work closely with the Secretary/treasurer to arrange for payment of all bills concerning the convention. Motion made by Peggy Brush, seconded by Sharon Hahn; passed.
- o Section 14 of the convention guidelines states: Waive convention fees for the convention manager and assistants. UMECRA should pick up the cost of the convention manager's hotel room for two nights. After discussion of this section, the 'and assistants' was eliminated. Motion made by Max, seconded by Julie; passed
- Standard Operation Procedures (SOP): a discussion was held as to where items such as the 'convention guidelines' is and why is it not available to members? There are several items that would fall into a SOP type document. Motion made by Julie, seconded by Marty to write up any SOP's that UMECRA has going forward and place them on a section of the website for all members to view. Motion passed. Jill has a SOP format and will put the convention

- guidelines in that format. Jill will also talk to Joslyn (UMECRA webmaster) about the web page.
- 1000-mile horse program: A motion was made by Theresa, seconded by Angie to cap the 'buy-back-miles' at \$50. The nomination fee of \$10 will stay as it currently is and the miles per year will remain at \$15/year with a cap of \$50 total for the miles (\$10 fee is still required before a rider can purchase the past year miles). A discussion was held as to the reason for the fee; in past years it was a lot of work to go back to past years to figure up the miles of horses as the records were not electronic. Due to technology, this backtracking may not be hard to do. This discussion was tabled until fall. Angie (new points keeper) will work with the point's database to see how much work is involved with this process. (Note: miles from years before the technology may not be assessable to purchase as the whereabouts of those records is unknown). No further action was taken on this subject at this time.
- Rider and horse numbers: Motion made by Peggy B, seconded by Theresa that all horses and riders in UMECRA have a number for tracking of points. Angie would assign the horse numbers and Jill would assign the rider number. Jill and Angie will work together to set up a system and report back at the fall meeting. No other action was taken on this subject at this time.
- Trail fund: this subject was tabled from the January meeting. How can UMECRA fund the trail fund to be sure there is money available for trail requests? The fund it given money from the silent auction; 75% is ICF, 12.5% is trail, 12.5% is scholarship money. This only puts money in the fund every other year. UMECRA is registered with Country Supply (now Horse.com). When members go on this site and order products, they can register to have points awarded to UMECRA. After so much in sales, UMECRA will be sent a check based off of the member's purchases. A discussion was held about who benefits most from all the different funds in the UMECRA treasury. A committee was formed: Jill, Peggy B., Dawn and Sharon. This committee will look at how UMECRA money is being generated and spent, look at trends and if any fees such as membership, rider fees, sanctioning fees, etc need to be increased in 2010. The money in UMECRA is decreasing slowly over the years and this committee will provide a report in fall.
- Elevator rides: a discussion was held about changing the UMECRA rule which bands elevator rides. There was discussion concerning how this rule change would affect endurance and competitive rides, what extra things a manager would have to do, the fact that some trails would not allow an elevator ride to work, etc. This topic was tabled until the fall meeting so more thought can be put into the wording the rule.
- Appointed position: a member expressed an idea that the appointed positions should be appointed in the fall meeting instead of in January. This time change would allow for a better transition period with the outgoing and incoming

personnel. The positions would be appointed in November at the fall meeting, but would not take on the duties until January. Motion made by Jill, seconded by Wayne; approved.

- Database: Angle asked for permission to purchase Access 2000 from Amazon.com. She needs the program to work with the new database that was developed for UMECRA. The cost of the program is \$65. Motion made by Theresa, seconded by Peggy B; approved.
- Awards: Maxine expressed concern about the cost she has to work with for the awards for the 2009 season. The amount allowed for awards is based on the ride entries from the previous season. In 2008, the ride entries were down over 400; this gives the awards committee an amount of \$19.70 & 39.40 to work with. Several board members expressed an interest in being on the awards committee and helping 'shop' for awards. These members are: Angie, Lynn and Dawn. They will work with Max to find some awards within this price range. If no awards can be found by June, the amount for awards will be reconsidered by the board for an increase. The increased cost would come from the general treasury.
- Novice Division: Tony Troyer brought a concern to the board about some senior, experienced riders who would like to ride in the 12-15 mile rides, but receive awards. Can a senior division be started? Tony stated that just a champion and reserve champion could receive awards and he was looking for a corporate sponsor for this. There were several comments and guestions about this topic. Is a 15-mile ride really endurance? Should UMECRA support the shorter distances? The novice is a starting point; should there be an ending point for riders? Should an open division be started? Could these riders be the leaders of the novice groups? Ride managers could contact one of these riders and provide free camping for the weekend and a free ride entry if he/she leads the novice division. The miles would count, but no awards would be given. Some of the breed organizations only consider a competitive ride as 25 miles or higher so the lower miles would not count toward breed awards. No action was taken at this time.
- Membership committee: Marty Power will be chair of this committee. Members include: Linda M, Julie, Angie and several UMECRA members (non board members) who have expressed an interest.
- ICF funds: Julie proposed an idea to use the ICF funds to assist UMECRA ride managers hold FEI rides. By using these funds for this purpose, more UMECRA members would benefit than just providing money for one rider to go to an international ride. FEI rides in the Midwest could be very educational for all riders and keep our riders here. FEI riders are forced to leave the region to qualify at FEI rides. By going outside the region, they are missing UMECRA rides and not contributing to their support. The ICF members will be contacted about this proposal.
- Fall and spring meeting locations: Should we move these meetings to different locations? Julie put some

## What Horse Owners Should Know About Strangles

Strangles is a highly contagious disease that causes horses to have swollen and painful lymph nodes that block their airway and can cause difficult breathing. The name was coined because these enlarged nodes sometimes (but rarely) suffocate affected horses.

The first reported case of strangles in a horse was in 1251 by Jordanus Ruffus in Europe. Convinced of its contagious nature, Ruffus recommended isolating affected animals and pointed out that the most common source of infection for horses was water buckets previously used by infected animals. This advice remains valid today.

Here are some common questions and answers about strangles:

What causes strangles and what should I expect to see? Strangles is caused by the bacteria Streptococcus equi (commonly known as S. equi), which gains access to a

horse either through the animal's nose or mouth. Bacteria then invade the lymph nodes in the head and throat area, making them swollen and painful. With time, abscesses in the lymph nodes will mature and rupture to drain a creamy pus. Other lymph nodes in the head and throat may be involved but not be apparent because many of them will drain into the horse's throat and nasal cavity.

Additional signs of the disease that often develop include fever, loss of appetite and listlessness.

How does a horse become exposed to strangles? Most horses that develop strangles contract the disease through contact with the infected nasal discharges from another horse that has an active case of strangles or has recently recovered from strangles. Direct transmission occurs when horses, being very social creatures, have nose-to-nose contact with each other. Indirect transmission occurs when a susceptible horse shares feed, water buckets or housing with an infected horse.

About 20% of horses continue to shed S. equi in their nasal secretions for several weeks after they have recovered from the disease, making all recovered horses a potential source of infection for at least six weeks after clinical signs have resolved. An extremely small percentage (1% to 10%) of horses continue to shed S. equi in their nasal secretions for months to years. These horses frequently have guttural-pouch infections caused by S. equi.

Fortunately, S. equi is not a hearty organism and does not persist for long in the environment. While it is possible that a horse could contract strangles from the pasture that housed a horse with strangles, it is very unlikely.

How will a veterinarian know if a horse has strangles? A veterinarian generally will diagnose a case of strangles based on the classical clinical signs. The gold standard to confirm the infection is a bacteriologic culture from either nasal swabs or pus from the abscesses. Another test is a polymerase chain reaction (PCR), which detects the DNA of S. equi. While this test is excellent, it does not distinguish between dead and live organisms and therefore should not be used alone to make a diagnosis of strangles.

What should be done if there is a strangles outbreak? Proper management by the horse owner or the farm manager is the key to the successful control of an outbreak of strangles. Working with a veterinarian, the owner or farm manager can identify affected groups of horses, look at the geography of the premises and review management practices to develop a practical disease-control strategy.

Several specific aims of the plan should include:

- 1. Preventing the spread of S. equi infection to horses on other premises and to new arrivals on the infected premises. This is done by stopping all movement of horses on and off the affected premises until further notice. Horses with strangles and their contact should be maintained in well-demarcated "dirty" quarantine areas. Clustering the cases in groups should allow parts of the premises to be allocated as "dirty" and other parts as "clean."
- 2. Establishing when horses that have recovered are no longer infectious. The veterinarian will institute a program of culturing nasal swabs over several weeks. Horses that consistently test negative are returned to the clean area.
- 3. Investigating long-term carriers. If a horse continues to shed S. equi longer than expected, the veterinarian will recommend an endoscopy examination of the guttural pouches and determine treatment if needed.
- 4. Preventing infection spreading from dirty areas to clean areas of the premise. Ideally, the individuals working with horses should be divided to deal with each of the two groups of horses. If this is not possible, horses in the clean area should be attended to first. The veterinarian will also be able to describe methods of disinfecting facilities.

Is it possible to vaccinate against strangles? Field experience suggests that vaccinating horses usually reduces the incidence and severity of strangles. However, vaccination is not an absolute preventative. Researchers are actively working to develop improved strangles vaccines to protect horses from this highly contagious disease.

#### Fast Fact!

Most of the time, a horse has "monocular" vision. This means a different image is seen by each eye so that a horse is seeing two different pictures at the same time. A horse can also have "binocular" vision. Binocular vision is when both eyes work together to see one picture (humans have binocular vision). A horse only has binocular vision when it is looking down its nose.

### **SCRATCHES**

Tis the season! Nothing like a muddy spring for your horses to end up with a nasty case of scratches!

Here's what Horse Journal (February 2009) recommends:

Start with daily cleaning using a tea-tree based sheath cleaner – it's antimicrobial action helps clean and treat any mild infections.

Leave it on for about 5 minutes to help soften the scabs and make them easier to remove.

Sometimes that's the only treatment needed if you catch it early enough.

Still a problem – coat the affected area with Desitin (diaper rash ointment), clear aloe gel or Corona. Application of a Telfa type pad and wrap can help keep the area dry and clean.

If it doesn't clear in a few days you might need to be more aggressive.

Here are two options to try:

- 1. You can use a 50:50 mixture of Lotrimin cream (yep athlete's foot cream) and a triple antibiotic wound cream.
- 2. In a small bowl, mix the following ingredients: 1 tube of 1% hydrocortisone cream, 1 tube of triple antibiotic cream, 1 tube of Lotrimin, 2 tbls of water based aloe-vera cream (must have water as the main ingredient not mineral oil), the contents of one 1,000 IU vitamin E capsule, and the contents of one 10,000 IU capsule of vitamin A.

Apply daily until the scratches are healed. If you don't see results within 3 days, try a different treatment.
