Run For The Cactus and Run For The Ridge have a NEW LOCATION!!

Both rides will be held at Huntersville State Forest, between Bemidji and Brainerd.

This is a beautiful venue!!! The camping will be in a huge pasture, with LOTS of space for everyone and their friends.

You can tie to your trailer or put up pens. There will be water available as well as porta-potties. \$28/night per rig.

The trails have excellent footing: not many rocks at all; it's mostly dirt, sand, grass and much of it is 2-track. The sand isn't deep and most of the trail is barefoot-friendly. We will be on some forestry roads which are like minimum maintenance roads, but any gravel is fairly fine. The terrain is flat..easy for a first-time 100-mile! We will also be on some gorgeous single-track trail that is windy and mostly trot-able, so lots of fun. This venue also handles rain well; YAY!!

The Outpost Bar and Grill is about 100 yards from the campgrounds. They will be catering our Saturday supper, so there's no need to bring anything for a Potluck. The meal will be included in your camping fee, so please let me know if you are coming, and how many people will be eating. Camping will be \$28/night per rig. The Outpost will be open for Breakfast, Lunch and Dinner, and they have fabulous food and a well-stocked bar. The burgers are amazing!!!

There is a shallow river where the horses can get water. The footing is firm: sandy with fine gravel, and the water is crystal clear. The river is also within walking distance from the campgrounds, so bring your swimsuits to cool off after a warm day. Our campground host rents canoes and kayaks just down the road.

I hope we have a HUGE turnout for Cactus! This should be a super fun ride and then we get to do it again in September for the Ridge. See you there!!!!!

The Enigma of Getting Pulled and Rider Recourse.

There are many reasons for getting pulled other than lameness or compromised metabolics—lesions on the horse's body, horse abuse (whipping, spurring out of control, or just obnoxious meanness to the horse) or abuse of ride personal (RMs, vets, timers or pulse takers) and infractions of other rules outlined in the AERC Rules and Regulations. However my intent is to address the situation of a horse being pulled by the vet staff for metabolics or lameness.

Many decisions made by the vet staff are subjective, based on the objective evaluations gleaned from the 'substantive' evaluation by filling out the rider card. The veterinarian makes a decision as to whether a horse is 'fit to continue' metabolically based on his/her own experiences in determining the medical condition of the horse. Because 'metabolics can kill' vets do put a heavy emphasis on the metabolic evaluation in determining the 'fit to continue' condition of an entrant. Those horses that have an unacceptably high risk of developing serious metabolic lesions have to be identified and removed from competition. There cannot be any second guessing when it comes to metabolics because of the seriousness of the consequences. Many times horses are rechecked at a vet check if there are questions. They are, however, examined very critically to determine their condition and not released for further competition unless they show

good recovery from the stress of the ride and that they are 'fit to continue'.

The lameness evaluation is done with the horse trotting straight out and back to show if there is any aberration of gait. Quoting the Guidelines for Control Judges and Treatment Veterinarians at AERC Endurance Competitions page 23, "It is not always possible or necessary to make a definitive lameness diagnosis; however, it is incumbent upon the control judge to make a subjective evaluation of the horse's gait specifically as to whether the standard of "fit to continue "has been met." On page 20 of the Guidelines, under the section entitled Criteria. subtitle Gaits, it says: "Decisions to pull a horse with a Lame code should be based on an exam in which the lameness can be localized to one or more legs with a reasonable degree of confidence. Doing so improves consistency of decisionmaking between individual control judges and helps avoid nebulous lameness pulls."

Judging lameness is not all that clean cut however. The exam is done at a trot straight out and back, sometimes the length of a CRI (Cardiac Recovery Index), 125 feet out and back. There are no palpations done as in a hands-on examination. The identification of a Grade III lameness is grounds for elimination. This is described in the Guidelines on page 24 under <u>Definition: Lameness is a deviation from the normal gait or posture due to pain or mechanical dysfunction.</u>

Grade III lameness is defined on page 24 of the Guidelines: Consistently observable at a trot under all circumstances. At endurance competitions, this generally means consistently observable in both directions of a straight outand-back trot. (Note: as a general rule of thumb, "consistent" can be defined as observable more than 70% of the time.)

After having attended the Lameness Examination sessions at the AERC veterinarians continuing education classes it has become apparent to all that this rule of thumb means that a lame horse will take a lame step 7 out of 10 steps or more as it trots out. We have taken this approach to

evaluation of the gait to try to establish some consistency to the exam.

This aberration of gait is generally manifested by the raising of the horse's head up when the horse bears weigh on the sore or lame front leg. The head comes down when weight is borne on the sound leg. A rear leg lameness is manifested by the hiking (or raising) of the horse's hips when weight is born on the sore or lame rear leg. This raising of the head or hiking of the hips is done by the horse to take weight off of the lame limb in the weight bearing state. This description is an over simplification of the whole topic of lameness manifestation but for the cases of this paper I have chosen to use these scenarios.

Vets need to identify the lame limb. Once again, the Guidelines state on page 20: "Decisions to pull a horse with a Lame code should be based on an exam in which the lameness can be localized to one or more legs with a reasonable degree of confidence." The lameness should be identified as to the limb the horse is lame on. The vet should be able to point out to the rider what leg the horse is manifesting the lameness on. The Guidelines, however, do state on page 23: "It is not always possible or necessary to make a definitive lameness diagnosis: however, it is incumbent upon the control judge to make a subjective evaluation of the horse's gait specifically as to whether the standard of "fit to continue" has been met.

Guidelines on page 24 state: <u>"The Lame code is</u> used when any equine is found to be consistently observably lame by the control judge, generally considered at least Grade III lameness as defined by the AAEP standards. Where possible it is beneficial and advisable to have two control judges confer on the presence and degree of lameness before retirement of the horse from competition.

I have quoted the Guidelines as much as possible to make my points in this paper and to give them credence. My personal intent when judging an endurance ride is to be able to identify the lame leg beyond a question when declaring a horse not 'fit to continue'. I always instruct those vetting with me that when they recognize lameness in a

horse that they be able to identify the limb that the horse is lame on. Then whether it is I or my colleague we are to watch the horse trot out and concur on the fact that the horse is lame and also which leg the horse is lame on. This is to me a necessity.

The phrase: "I think there is something going on in the hind end" is not satisfactorily identifying the lameness, especially as to which leg the lameness is in. There are times when a horse may not be 'right' and perhaps a Grade I or II which is not enough to pull the horse. These lameness's are hard to put a handle on but the veterinary staff should watch the horse move and concur on the Grade and as best as possible on the limb affected. Grades I or II are not pulls and can be certified 'Fit to Continue'. If they occur at the end of the ride the horse can be given a completion. Grade III lameness with lame steps 70% of the time on a straight out and back trot are not 'Fit to Continue' and do not warrant completion.

Having said all this, I quote AERC Rules and Regulations Rule 2.1.5: "The control judges' decisions regarding disqualification must be final and ride management must stand behind the control judges' decisions."

This rule weighs heavily on a control judge. On the one hand he/she is ultimately responsible for the 'welfare of the horse' and on the other hand he/she must render a fair and just decision that is acceptable to the rider---the rider who can be a highly competitive individual having spent hours on the ride being judged ---also having spent hours, days, months and many dollars on a year's accumulations of points. This responsibility weighs heavily on the shoulders of ride veterinarians. Protection of the horse is the ultimate responsibility however.

What recourse does a rider have when they get pulled at a vet check? This is a loaded question mainly because one is usually going against the opinion of the veterinary staff of the ride. This is the question that has prompted me to write this paper. It is a good that those of us who have competed have had on our minds when we have found ourselves in the position of being pulled at

a vet check or not being granted a completion at the end of a ride.

I think realizing that we as riders usually can be granted the option of a re-presentation sometime within the hold time of a check or sometime within the one hour presentation time for a completion gives us some reprieve. At that representation, if one has a real doubt or wants to see what the veterinarian is seeing we can get someone else to trot out the horse so we can get a better idea of what the vet is seeing. As a veterinarian watching a re-presentation I want the second vet to watch the trot out also so that the rider can be assured that the opinion is not just that of one vet. After that trot out the vets will agree on the lameness and which leg the horse is lame on or there may be another trot out. The vets should discuss the case at that time and reach a consensus of opinion.

Many times the decision is not as simple as I have illustrated and this is why at high profile and FEI rides there is a panel of 3 judges that vote secret ballot on every finish trot out and on every re-presentation. The majority rules on each vote. No one knows how a vet voted so no-one can be accused of bias.

This is the scenario on lameness questions. Metabolic questions can be treated the same with more than one vet examining the horse and rendering an opinion. These are discussed and a decision arrived at. A CRI is very useful to use at this point. Once again this is the procedure that is used at high profile rides.

The reality is that the decision of the veterinarian (one or multiple) is final. We as ride vets do work hard to guard the welfare of the horse and also to satisfy the rider's desire to get a fair and unbiased decision. We as riders pay an entry fee for this procedure to occur at the ride with confidence that ride vets know the rules and know the physiology of endurance horses well enough to do a satisfactory job.
